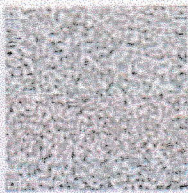

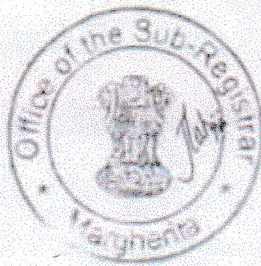

WHEREAS having felt the need for a good institution for the residents of Digboi and the adjoining areas in which can be imparted proper education to the pupils and also having increasingly felt the need to expand the scope, span and area of operation of the school and also for its proper management and administration, the SETTLER has settled on TRUST a sum of Rs. 10,000/- (Rupees ten thousand only) which shall form part of the CORPUS OF THE TRUST.

AND WHEREAS the TRUSTEES having consented to act as FIRST TRUSTEES of these presents accepted the TRUST under these presents as testified by their being parties to and executing the same and that for the consideration aforesaid (copies of which have been submitted to the TRUSTEES for acceptance), the trustees hereby covenant with the SETTLER that they the TRUSTEES shall hold and stand possessed of the said amount) which is herein after for brevity's sake referred to as the CORPUS OF THE TRUST or TRUST FUND which expression shall include cash of Rs. 10000/- into which the same or any part thereof might be converted, invested or varied from time to time or such as may be acquired by the trustees or come to their hands by virtue of these presents or by operation of law or otherwise however in relation to these presents) upon the TRUST and with and subject to the power, provisions, agreements and declarations hereinafter declared of and concerning the same.

NOW THIS INDENTURE WITNESSES AS FOLLOWS :

01. The entire amount of Rs. 10,000/- only shall be the TRUST PROPERTY and can not be claimed by the Settler as his own and individual property or by any of the Trustees. Henceforth the aforesaid property shall devolve unto the trust under the name and style of the trust as "JADO LAL MEMORIAL TRUST FOR EDUCATION AND SOCIAL SERVICES" with immediate effect.
02. The trustees so declare that they, the trustees, shall hold on and stand possessed of the said amount of Rs. 10,000/- as the initial CORPUS FUND of the trust.
03. The registered office of the trust will be located at Borbil No.1, A.T.Road, P.O. & P.S Digboi - 786171, Dist. Tinsukia, in the State of Assam, or at such other place or places as the trustees may decide from time to time.
04. The Trust hereby created shall be irrevocable Trust
05. The Trust hereby created shall impart quality education to all pupils of Digboi and nearby areas irrespective of their caste, creed or religion and that no benefits shall accrue to the settler or the trustees of the Trust and there shall be no application or use of income or property of the Trust for the benefit of the settler or the trustees.

- 06. The Trust hereby created shall solely use all the funds of the trust including its property for the objects as laid down hereafter for which the trust is created.
- 07. The Trust hereby created shall be solely for charitable purpose only and any surplus generated or property acquired during the course of its activities shall be used solely for better enhancement of its objects as laid down hereunder and no part of income or property of the Trust will be used or applied for the benefit of person specified u/s. 13(1) (c) of the Income Tax Act, 1961.
- 08. The Trust hereby created shall not carry on of any activity in the nature of trade, commerce or business, or any activity of rendering any service in relation to any trade, commerce or business, for a cess or fee or any other consideration.

09. THE OBJECTS OF THE TRUST ARE

- 1. To open, run, continue an educational and vocational school or institution in healthy and salubrious surrounding and that the Trust hereby created shall exist for the purpose of education only.
- 2. To engage teachers, professors, instructors and experts of good moral character and conduct who will be able to impart efficiently and economically up-to-date education and instruction to pupils and students in modern sciences, literature, industrial vocations, research work, intellectual and other useful pursuits.
- 3. To develop a healthy as well as critical attitude towards the development of mental, physical and moral uplift of the students and all those connected with the institution so as to make them good citizens.
- 4. To establish, maintain and run a boarding house and residential institution for the students and those connected with the institution.
- 5. To invest, dispose of, transfer and otherwise deal with the subject-matter of the trust in such manner as the trustees should deem fit so as to enable the society to carry on the objects of the trust effectively.
- 6. To accept donation, grants, presents and other offering and to deal with the same for the purpose of the trust.
- 7. To charge moderate tuition fees and otherwise recoup themselves for the outlay and expenses incurred in the upkeep and maintenance of institutions established or about to be established under the deed.
- 8. To train and equip the pupils so as to be self-supporting in an honourable and decent way of life so as to develop into good, healthy and progressive citizens.

4. That any vacancy in the office of any of the permanent trustee shall be filled up by a majority decision of the other remaining trustees.
5. That SRI TRILOK KUMAR GUPTA shall be the Managing Trustee with the execution of these presents and after he ceases or retires or becomes unfit or incapable to act as Managing Trustee, the permanent trustees shall appoint a trustee from amongst themselves as the Managing Trustee of the Board who shall hold the office till the term as decided by the trustees.
6. That the permanent trustees shall appoint a Secretary of the Board of Trustees who may or may not be a trustee and shall hold the office till the term as decided by the trustees.

12. MEETING OF THE BOARD OF TRUSTEES

There shall be at least three meetings in a year and notice of the meeting shall be sent to the Trustees at least 15 days before the date of the meeting. Half of the total number of members shall form the quorum. Any fraction shall be taken as one. The Managing Trustee shall be the Chairman of any meeting and in his absence SRI DURGAWATI GUPTA shall temporarily act as Chairman.

13. EFFECT OF APPOINTMENT OF NEW TRUSTEES

Upon every such appointment made in pursuance of the last forgoing clauses thereof, the newly appointed Trustees shall have powers and authorities of a Trustee under THESE PRESENTS.

14. CEASETION OF TRUSTEE

That a person shall cease to be a trustee on any of the following eventualities comes to pass:

- i) if he/she dies,
- ii) if he/she without leave of absence in writing does not attend three consecutive meetings of the Board of Trustees,
- iii) if he/she is adjusted an insolvent or is found to be a lunatic or of unsound mind by a Court of competent jurisdiction,
- iv) if he/she is convicted of a criminal offence involving moral turpitude,
- v) if he/she resigns his/her office,
- vi) If he/she goes to reside out of India for more than three years.

15. POWER AND DUTIES OF THE BOARD OF TRUSTEES:

- (a) The Trust may receive donations of money and or properties when received shall be at the absolute disposal of the trust. The Trustees may acquire/ purchase any property or any existing school which shall be carried on / managed / administered under the various provisions of this Trust.
- (b) The Trustees shall invest the properties and money of the Trust in such manner as prescribed under sec. 11 of the Income-tax Act, 1961 and other statutory laws.
- (c) The Board of Trustees shall meet as often as necessary and their proceedings shall be recorded regularly in the Minutes Book to be retained for the purpose, in the resolution to be passed touching the administration of the Trust, the opinion of the majority shall prevail. It shall be competent however for the Trustees to decide matters by circulation, in case there being equality of votes, the Chairman of the meeting has casting vote for the purpose of deciding the issue.
- (d) The Permanent Trustees may open and operate current or deposit or other accounts with any Scheduled Bank or Banks and the same bank account shall be operated by joint signatures of the Managing Trustee SRI TRILOK KUMAR GUPTA.
- (e) The Board may by resolution extend the activities of the trust or undertaken any activity in furtherance of the main object of the Trust.
- (f) Proper books of accounts shall be maintained of the Trust and shall be audited by a Chartered Accountant as may be appointed by the Board of Trustees.
- (g) To do such other lawful things as are incidental in carrying out the administration and management of the Trust.
- (h) The Trustees shall maintain the Minutes Book in which the proceedings of all meeting of the Trustees shall be recorded by the Trustees and the same shall be signed by the Chairman of the Meeting.
- (i) The Trustees may frame rules and regulations as to the duties and responsible of each Trustees, to appoint sub-committees, mode or conducting any other matters connected with the administration of the Trust and its management.

16. POWERS TO APPOINT COMMITTEES:

The Board of Trustees shall be entitled from time to time to appoint with or without remuneration and on such terms and conditions as they may think proper, to appoint Committee as they may think proper to function under the Authority and control of the Board of Trustees for carrying out the objects of the Trust of these presents or the management thereof and invest them with all such powers including power to incur all such expenditure as may be necessary for carrying out the object of the Trust.

17. POWER TO DETERMINE ALL QUESTIONS OF DOUBT OR DIFFICULTY:

It shall be lawful for the Board of Trustees to settle and determine all matters of interpretation of THESE PRESENTS as well as matters of difficulty, doubt or dispute and all questions arising in the course of or incidental to the administration, management and execution of the trusts and powers of THESE PRESENTS and any such settlement or determination shall be valid, binding and conclusive and shall not be objected to or re-opened upon any ground whatsoever.

18. POWER TO COMPROMISE:

The Board of Trustees shall have full powers to settle compromise or compound, our of court, all suits, action and other proceedings and to settle all or other proceeding, difference of demand and adjust the settlement of all accounts relating thereto as fully as if they were absolutely entitled to the trust fund and without being answerable for the loss occasioned thereby.

19. POWER TO PURCHASE, HIRE OR TAKE ON LEASE:

The Board of Trustees shall be entitled to purchase or hire or to take on lease a property or properties for the purpose of carrying out the objects of the Trust hereby created.

20. POWER TO BORROW:

The Trustees may from time to time, at their discretion for the furtherance and carrying out the objects of the Trust of THESE PRESENTS, borrow such sum as may be determined by the Board of Trustees from time to time in form and manner thereupon. The Trustee shall, at their discretion, make all such dispositions of the properties movable or immovable forming part of the Trust Fund or any part thereof and enter into such agreements, assurance and things in relation thereto as the Trustees may deem proper for giving security for such loan and interest.

21. INVESTMENT OF TRUST FUND:

All money forming part of the Trust Fund and requiring investment shall be investment in any of the securities authorized by law for investment of Trust Funds which are permissible under section 11(5) of the Income-tax Act, 1961 or shall at their discretion sell and / or realize the same or any part thereof.

22. IN WHOSE NAME MONEY TO BE INVESTED:

All money forming part of the Trust Fund and requiring investment shall be investment and the conveyance of assurance in respect of any immovable property / properties forming part of the Trust Funds shall be obtained in the name / names of the Trustees for time being of the Board of Trustees.

23. POWER TO SELL THE IMMOVABLE PROPERTY AND MANAGE:

(a) The Trustees shall have the power to buy, acquire, take on lease any property, movable and immovable that may be needed to carry out and further the objects of the Trust and incur all such expenses connected therewith.

(b) The Trustees shall, manage any immovable property or properties for the time being forming part of the Trust Fund in such manner as they shall think fit with full power to make improvement, repairs or alterations of any description and to make or incur any outlay for any such purposes or for the insurance or otherwise for the protection of benefits of the said premises and to grant or renew leases or tenancy of occupation and to make any agreement with tenants or occupiers or intending tenants or occupiers.

(c) The Trustees shall, if the need arises, sell or assign or lease any movable or immovable property or properties for the time being forming part of the Trust Fund together or in parts for the purpose aforesaid or any of them to execute and do all such assurances, acts, suits and things as they shall think fit.

24. RECEIPTS OF THE TRUSTEES

The receipts in writing by the Managing Trustees or any other person authorized by the Board of Trustees of any interest, dividend or income of the Trust Fund or for any deeds, papers, writing documents or other monies and effect payable to the Trustees shall be sufficient and effectual discharge for the same. The Board of Trustees by a resolution may also authorise any scheduled bank or other banks in India to collect any interest, dividend or income of the Trust Fund on their behalf.

25. POWER TO AMEND THE RULES

If in the opinion of the Trustees, circumstances so require, the Trustees may unanimously make any amendment in the rules, they may consider necessary for the better management or administration of the Trust activities or for carrying out the objects of the Trust.

26. POWER TO MAKE RULES AND REGULATIONS

In addition to the aforesaid rules, the Trustees, shall from time to time, be entitled to make rules and regulations for the administration and management of the Trust of THESE PRESENTS and all matters incidental to or concerning the same PROVIDED, such rules and regulations shall not be repugnant to or be inconsistent with the provisions of the purpose of the Trust thereof.

27. POWER TO AMALGAMATE OTHER TRUST OR VICE VERSA

The Trustees Shall be at liberty to allow or to be allowed and permit, or to be permitted to amalgamate or to be amalgamated with any other Trust, Institution or Charity, in any areas or area whose objects are the same or similar to those of THESE PRESENTS, PROVIDED, they are not inconsistent with or repugnant to the objects hereof.

28. INDEMNITY TO THE TRUSTEES ETC.

The Trustees for the time being of THESE PRESENTS, shall be chargeable only for such monies, stocks, funds, deposits and securities as they shall actually receive notwithstanding their signing of any receipt for the sake of conformity and shall be answerable or accountable only for their own acts, receipts, neglects, defaults, and not for those of others or any banker, auctioneer or any other persons with whom or into whose hands any trust monies or securities may be deposited in accordance with THESE PRESENTS nor for the determination or loss of any stocks, funds, deposits or securities nor for any defects or insufficiency of title nor any other losses unless the same shall happen through their own neglect or willful demeanor.

29. POWER OF REIMBURSE:

The Trustees of THESE PRESENTS are entitled to be reimbursed and also to pay and discharge out of the Trust Fund, all expenses incurred by them or on their behalf in or about the execution of the Trusts and powers of THESE PRESENTS in accordance with the decision of the Board of TRUSTEES.

30. POWER OF APPOINTMENT:

To appoint and dismiss and re-appoint lawyers, accountants, clerks, teaching and other staff and other employees on such salary / remuneration and on such terms as they may think fit. For the removal of doubts, it is hereby expressly provided that if any one of the Trustees is engaged or employed for teaching as full time teacher in a school or other institutions of the Trust, then such Trustee shall be entitled to receive such reasonable salary for his services or may be decided by the Trustees.

31. POWER OF DELIGATION:

To delegate by power of attorney or otherwise by way of resolution to any Trustee or Trustees or any other person or persons powers and authorities implied by law or conferred by statute or vested in the Trustees by these presents The Trustees shall, however, not be held liable or responsible for the acts or defaults of any such person or persons but only for their own respective acts and defaults.

32. POWER OF RETENTION:

That the Managing Trustee shall have the custody of these presents, and of the books of accounts, minute book and other documents and /or records of the Trust.

33. EXECUTION OF POWERS:

That for the accomplishment of the objects of the Trust of these presents and without prejudice to the generality of any powers hereby or by law conferred or implied or vested in the Trustees, the powers and authorities as laid down in clauses 15 to 33 hereinabove are hereby expressly conferred on the permanent trustees only. The remaining powers other than the powers laid down in clauses 15 to 24 are hereby expressly conferred on the Board of Trustees.
